#### REQUIREMENTS

#### EVALUATION AND SELECTION CRITERIA

An EUDE Business School Scholarship Selection Committee will meet to review and select the applications received and select the scholarship recipients until all the available scholarships are assigned. Among the criteria taken into consideration for the selection of the awards for this grant are:

- Score awarded to the student by the EUDE Evaluation Committee (academic profile, merit and academic credentials, social/volunteer experience).
- The geographical distribution of the candidates, taking into account the most important needs of the OAS Member States, according to the Human Development Index reported by the United Nations Development Program (UNDP).

- Place of origin of the candidate
- Gender component
- Number of applications by country of origin of applicants
- • engineering, humanities, etc.)
- Humanitarian situation in view of the current circumstances
- The potential impact of the applicant after the completion of the desired program.

#### RESPONSIBILITIES OF THE PARTICIPANT

The scholarship recipient will be responsible for covering the remaining percentage of the total cost of the program of study, not covered by the scholarship. Any additional expense incurred by the applicant to be admitted to the program is not reimbursable, nor does it imply an acquired right to receive the OAS-EUDE scholarship.



The scholarship recipient will be responsible for assuming all other expenses required by the program (for example: issuance of certificates or records, admission exams, graduation services, degree issuance, legalization of documents, etc.).

The OAS will not provide individual feedback on why an applicant was not selected for a scholarship.

Neither the OAS nor EUDE take any responsibility derived from the acceptance or not of degrees or diplomas of the educational entity, within the country of origin of the participant. If you want to know how to legalize, homologate and/or validate the degree obtained from EUDE in your country, we recommend that you request information about it from the Ministry and/or Secretary of Education in your own country.
